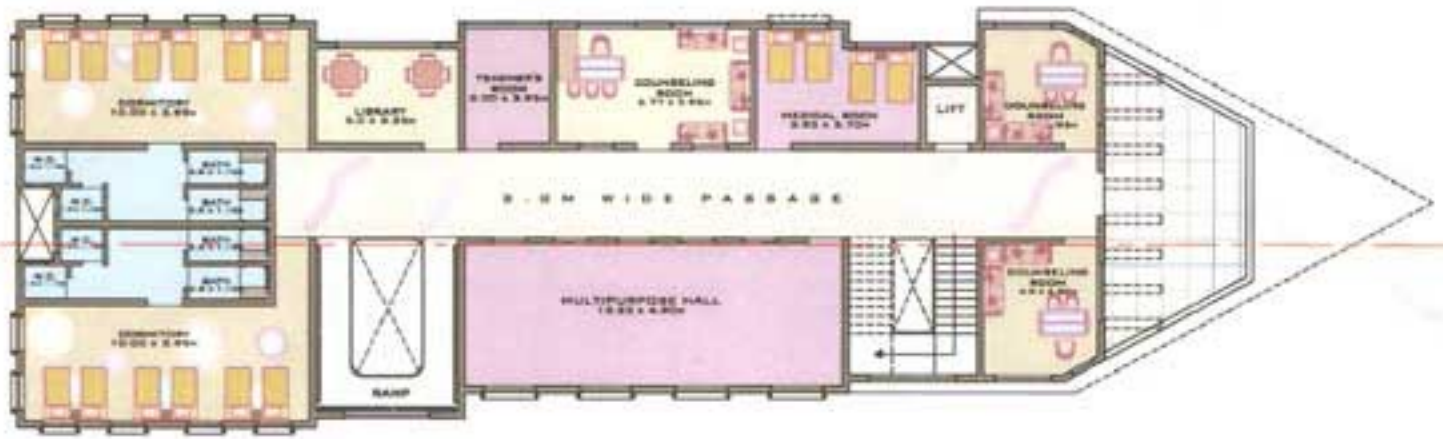

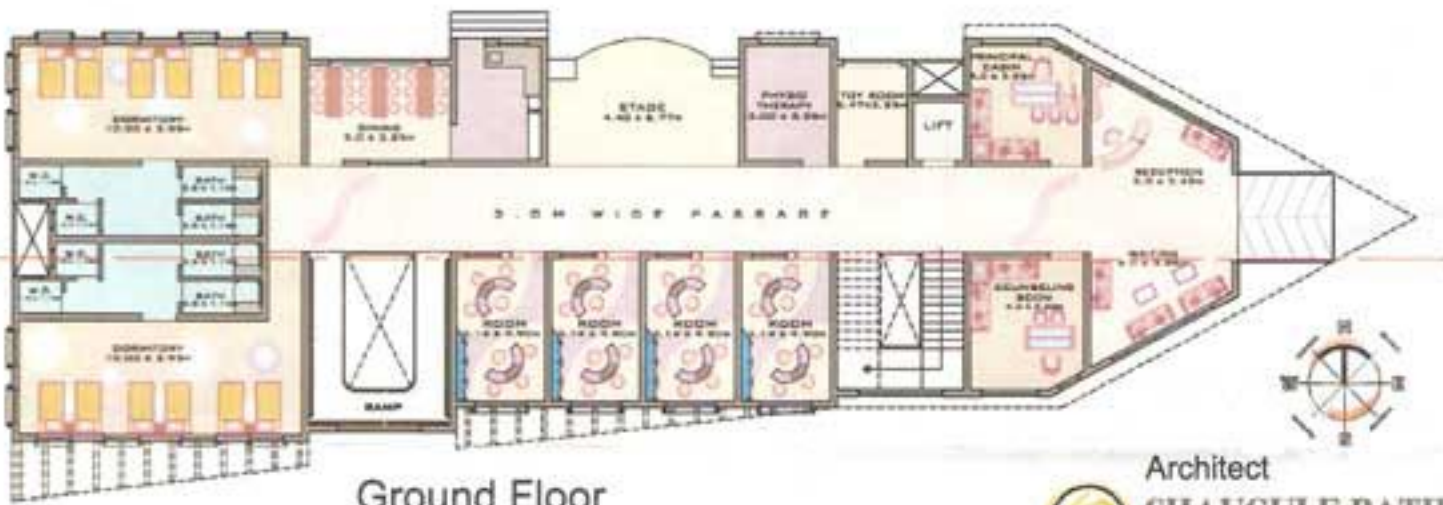

Our institute is engaged in the Education, Training & Rehabilitation of mentally challenged & Handicapped children. The Institute was engaged since **01/07/2002** to improve the intelligence level to teach educational scale to give experience of real pleasure of living. To achieve the right & equal opportunities & Protection for the mentally challenged handicapped. On **22/12/2004** Govt. of Maharashtra sanctioned our Special School for Mentally challenged on **permanently non-grantable basis**.

Our Institute is engaged in the field of special Education, Vocational training, Development & research activities the institute was inaugurated in the year 2002 with the strength of 3 students which has no date is **56**. This shows that the living society is in need of such activities. Four Special teacher to teach the prescribed syllabus, Art teacher to take care & explore their in built art of games, singing music etc. One Asst. teacher & Two care taker and One Driver are employed to get the best out of the students.

Hon. Psychologist, Hon. speech therapist, Hon. Medical officer & Psychiatrist. The reputed Medical practitioners viz Dr. Suresh Naik, Dr. Girish Datar, Dr. Suhash Kumbhar, visit our Institution for Medical checkup. Institute calibrates various Indian festivals in its campus to create awareness of Indian Culture. All national important days are celebrated such as Independence Day, Republic Day, World Disabled Day, World Mentally Retardation Day.

1] ART DEPARTMENT:

Various types of Drawings, Handicrafts, Painting. Programmes are conducted through out the year. In **December 2012** a state level Drawing competition arranged by **Daily Sakal**. In that event our student **Mayur Kashinath Vhankade** won the **first prize in State Level** in a category Mentally Retarded.

2] CULTURAL DEPARTMENT:

On **3rd Dec. 2012** Institute celebrated the "Worlds Handicapped Day" on this occasion all the students were taken to Miraj Balgandharva Natya Mandir in which our School students won **2nd prize in a cultural programme at Dist. level in MR. category**.

3] SPORTS DEPARTMENT:

Our students participated in the District Level sport at "District sport Club" Miraj on 28/11/2012. Our Students won the first prize in the competition to participate in the District level competition. **Miss. Jyoti Nana Pawar won first prize in spot jump & 200 Mtr. running. Miss. Pallavi Anil Koli won the second prize in Soft ball throw & 100 Mtr. running.** These students will be participated in state level sports for disable arranged by commissioneret (Disable) at Solapur in first week of January 2013.

At the end of each month the Institute arranges different activities such as Cleaning the roads, Gardens, Watering Plants, Tree Plantation etc. on 20/01/2013 a Trip was arranged at Iscon Mandir, Arawade, Tal:TAsgaon 28 students alongwith their parents.

4] TRAINING & DEVELOPMENT:

The employees in the Institute are special in their fields they used to present their report on the various education related subject time to time.

5] SOCIETY AWARENESS PROGRAMME:

On 8th March 2013 Mrs. Shalaja Goundaje, Ex. Director delivered her speech before ladies gathered **M.I.D.C. Police Station, M.I.D.C. Kupwad** on the eve of Womens Day on 3rd December 2012 on the eve of World Disability Day **Mrs. Shalaja Goundaje** given enterview on Yeralawadi F.M. Radio on various schemes for disable & persons with mentally challanged by National Trust and State Govt.

6] Free Medical Facilities:

From January 2010, All medical treatments under one umbrella have been started to our students at **MANAVRAHAT CHARITABLE TRUST SANGLI** [Premchand Ghodavat Diagnostic Centre] with the help of **Rajesh Vasantlal Shah** from **M/s. VASANTLAL M. SHAH & COMPANY, SANGLI**. We are highly thankful to Mr. Rajesh Vasantlal Shah for this contribution, and continuing the same scheme for this year **2012-13**.

7] Drugs for Epilipcy:

Most of Mentally Challenged Children are suffering from Epilipcy. Drugs for Epilipcy are highly expensive, those can not be purchased by parents as most of students are from low income category. Our foundation was in search of donor for supplying such a drugs to the beneficiary through us **Mr. Rajesh Vasantlal Shah, Sangli** accepted our request and from **June 2010** he is donating Epilipcy Drugs to **8 students** of which expenses are **Rs.2,500/- Per Month**. We are highly thankful to Mr. Rajesh Vasantlal Shah for this contribution, and continuing the same scheme for this year **2012-13**.

8] WORLD MENTAL RETARDATION DAY:

On occasion of World Mental Retardation Day **8th Dec. 2012** **Dr. Bhosale** from **Asha Homoeopathic Clinic Miraj** with his staff has started free Medical consulting for improvement in Mental health for our students also he is providing **free Homoeopathic Medicine every month**. **40** students taking benefit out of **8** have good results. We are highly thankful to **Dr. Bhosale B.H.** for this contribution, and continuing the same scheme for this year **2012-13**.

9] MID DAY FOOD:

Though our Institute is not granted by State or Central Government. Our best wishes & Donors indicated to provide free Mid Day food every day to the students. But due to financial problems it is very difficult to start every day but on a trial basis every Wednesday we are providing Mid Day food. All the expenses are borne by **Mr. Nigam Shantilal Shah**. This year many trading companies from **Market Yard, Sangli** donated food grains & allied materials.

10] About Eco Friendly Green School Building:

A] After getting building permission on 24/01/2011 we have started actual work on site by on 06/10/2011 [Dasara] we have taken Borewell [365 ft.] fitted 5 H.P. 25 stage 3 phase submersible pump with all adequate pipe line & fitting for drip irrigation purposes for plantation, Land development by tractor dozer excavation with JCB for plantation [2 x 2 x 1600 ft.] , fencing compound [1000 ft.] & Main gate [18 x 5 ft.] with R.C.C. platform [16 x 20 ft.] **The completed work is amount to Rs. 5,50,000/-.**

11] Architect Engineer :

Last 2 years M/s. Chougule-Patil Consultants Pvt.Ltd., are working with our foundation for completing the project [Special School & Sheltered Rehabilitation Centre] free of charge. We are highly thankful for their contribution towards foundation.

We hope your valuable co-operation will remain always with us. To rehabilitate a person with mentally disabled your contribution will not be a drop in the ocean, but your drop shall make the ocean which will wipe the tears from their eyes and big joy and happiness in their life. Your contribution towards this project will rehabilitate persons with mentally disabled.

The National Committee for Social Economical Welfare under Ministry of finance Department of Revenue Govt. of India recommended our proposal from file No.V.27011/266/2011-[NAT.com] to the Ministry. On 07/05/2012 our NGO as notified by Notification No. S.O.1030[E] for an amount Rs.2.55 Crore for A.Y.2012-13, 2013-14, 2014-15 which will help our doners to take benefit under provision of this section of the Act. For this proposal Mr. Vijay Navandar & Mr. Laxmanrao Gaikwad learned Chartered Accountants has given valuable time guidance and free of cost consultancy. Our foundation highly thanks for their valuable contribution which is not counted in money. Mr. Shantibhai Cheda , Sugat and Ganesh Group, Mumbai, Mr. M.V. Sundreshwarji CEO, Embathy Foundation, Mumbai, both have also given their valuable co-operation for this achievement.

The Commissioner (Disable) have directed to form such self help group for the disable & the parients on 12/12/2007. 16 parients are participeted in the group. On December 2008 we have started one more self help group in the name of **Kranti Visesh Mahila Bachat Gat**. 20 parients are participeted in the group. on **01/03/2012** we have started **Asha Visesh Mahila Bachat Gat**. These groups has distributed **Rs. 5,50,000/-** Loan among the members and **Rs. 11 Lakh** turnover achived upto **March 2013**.


