

Our institute is engaged in the Education, Training & Rehabilitation of mentally challenged & Handicapped children. The Institute was engaged since 01/07/2002 to improve the intelligence level to teach educational scale to give experience of real pleasure of living. To achieve the right & equal opportunities & Protection for the mentally challenged handicapped. On 22/12/2004 Govt. of Maharashtra sanctioned our Special School for Mentally challenged on permanently non-grantable basis.

Our Institute in engaged in the field of special Education, Vocational training, Development & research activities the institute was inaugurated in the year 2002 with the strength of 3 students which has no date is 95. This shows that the living society is in need of such activities. Five Special teacher to teach the prescribed syllabus, One Psycologist, Art teacher to take care & explore their in built art of games, singing music etc. Two Asst. teacher & Three care taker and One Driver are employed to get the best out of the students.

Hon. Psychologist, Hon. speech therapist, Hon. Medical officer & Psychiatrist. The reputed Medical practitioners viz Dr. Suhas Kumbhar, Dr.Girish Datar, Dr. B.S.Bhosale, visit our Institution for Medical checkup. Institute calibrates various Indian festivals in its campus to create awareness of Indian Culture. All national important days are celebrated such as Independence Day, Republic Day, Wold Disabled Day, World Mentally Retardation Day.

1] ART DEPARTMENT:

Various types of Drawings, Handicrafts, Painting. Programmes are conducted through out the year. In December 2016 a state level Drawing competation arranged by Daily Sakal. In that event our student Anuprita Petkar won the Second prize in District Level in a category Mentally Retarded.

2] CULTURAL DEPARTMENT:

On 3rd Dec. 2016 Institute celebrated the "Worlds Handicapped Day" on this occasion all the students were taken to Bhide Mukbadhir Vidyalaya, Miraj in which our School students won 2nd prize in a cultural programme at Dist. level in MR.catagory.

31 SPORTS DEPARTMENT:

Our students participated in the District Level sport at "District sport Club" Miraj on 29/11/2016. Our Students won the first prize in the competition to participate in the District level competition. Miss. Gouri Shinde won First price in spot jump & 100 Mtr. running. Miss.Dhanshree Koli won the first prize in Soft ball throw & 200 Mtr. running. These students will be participated in state level sports for disable arranged by commissioneret (Disable) at Nagpur in first week of February 2016.

At the end of each month the Institute arranges different activities such as Cleaning the roads, Gardens, Watering Plants, Tree Plantation etc. on 31/10/2016 a Trip was arranged at Narsobawadi 38 students alongwith their parents.

4] TRAINING & DEVELOPMENT:

The employees in the Institute are special in their fields they used to present their report on the various education related subject time to time.

5] SOCIETY AWARENESS PROGRAMME:

And Barrier Free Environment.

6] Free Medical Facilities:

From January 2010, All medical treatments under one umbrela have been started to our students at MANAVRAHAT CHARITABLE TRUST SANGLI [Premchand Ghodavat Dignostic Centre] with the help of Rajesh Vasantlal Shah from M/s. VASANTLAL M. SHAH & COMPANY, SANGLI. We are highly thankful to Mr. Rajesh Vasantlal Shah for this contribution, and contuning the same scheme for this year 2016-17.

7] Drugs for Epilipcy:

Most of Mentally Challanged Children are suffering from Epilipcy. Drugs for Epilipcy are highly expensive, those can not be purchased by parents as most of students are from low income catagary. Our foundation was in search of doner for supplying such a drugs to the beneficary through us Mr.

Rajesh Vasantlal Shah, Sangli accepted our request and from June 2010 he is donating Epilipcy Drgus to 10 students of which expenses are Rs.3,500/-Per Month. We are highly thankful to Mr. Rajesh Vasantlal Shah for this contribution, and contuning the same scheme for this year 2016-17.

8] WORLD MENTAL RETARDATION DAY/ HOMIOPATHY DAY:

On occation of World Mental Retardation Day 8th Dec. 2016 & World Homiopaty day 11th April 2017 Dr.Bhosale from Asha Homoeopathic Clinic Miraj with his staff has started free Medical consulting for improvement in Mental health for our students also he is providing free Homoeopathic Medicine every month. 90 students taking benefit out of 23 have good results. We are highly thankful to Dr. Bhosale B.H. for this contribution, and contuning the same scheme for this year 2016-17.

9] Approval U/s. 35 AC of IT Act 1961:

The National Committee for Social Economical Welfare under Ministry of finance Department of Revenue Govt. of India recommended our proposal from file No.161/2015/F.No.V 27015/1/2015-SO [NAT.com] to the Ministry of finance and renewed for an amount Rs.2.55 Crore for F.Y.2015-16, 2016-17, 2017-18 which will help our doners to take benefit under provision of this section of the Act. This caluse is omitted from 01/04/2017 we have colleted 2.21 Crore out of 2.55 Crore.

10] About Eco Friendly Green Sheltered Rehabilitation Centre Building:[Sujaya Sheltered Rehabilitation Centre]:-

We had applied for Grant-in-aid for construction of Sheltered Rehabilitation Centre estimated cost being around 1 Crore to Sujaya Foundation, Mumbai. Mrs. Nilambari Rao Trustee of the foundation visited our Institution & site, the foundation has sanctioned Rs. 66 Lakhs for the project. As per standing ramaining cost will be born by us. The tokan grant amount released by Sujaya Foundation initiated the start of work on 26/12/2013. Upto 31/03/2017 amounts spent on project is Rs. 1,83,71,681/- Rs. 61.00 Lack received from Sujaya Foundation and Rs. 5.00 Lack will to be received. The project is expected to complete by December 2016.

The Total porject cost (Ground + First floor) is about 2.50 Crore as earlier stated out of Rs. 66 Lacks sanctioned by Sujaya Foundation. The remaining constuction cost is managing by sponsring rooms, Dormetary, Theriepy rooms, Hall, Stage etc. The names of sponsered person / Company / the name suggested by them will be displaced on the room.

The Commissioner (Disable) have directed to form such self help group for the disable & the parients on 12/12/2007. 46 parients are participeted in the group. On January 2014 we have started one more self help group in the name of Kranti Visesh Mahila Bachat Gat. 30 parients are participeted in the group. on 01/03/2012 we have started Asha Visesh Mahila Bachat Gat. These groups has distributed Rs. 20,00,000/- Loan among the members and Rs. 25 Lakh turnover achived upto March 2017.
